#### 1. CALL TO ORDER

## 3. DISCUSSIONS & PRESENTATIONS

• Engineer Melanie presented:

- The Annual NPDES MS4 Notification. She read a report on the background and six control measures required. The entire document was shared and included in the meeting materials.
- The Resolution for the CDBG Grant Application for Roadway Improvements to 219<sup>th</sup> Place, between Merrill Avenue and Orion Avenue. She reviewed the intended projects for program submission. It is the same project that was not approved the previous year for \$400,000 with a match for \$125,00.

Notes: A question arose if the Village would move forward with the project, if not fully funded. A revised estimate would be presented. Competitive Bidding is required. The project must be included in the budget. Notice of the award is expected in September/October.

Review the Contract for CSL Sprinkling Cleaning

The RFP and Contract were reviewed. There were major ambiguities noted. Many Trustees stated their opinions on if the company should be paid \$1,00 for extra services rendered. It was noted that deviations and changes should have been brought back to the Board for reconsideration or rebidding. A Special Meeting was scheduled for February 28<sup>th</sup> at 6:30 p.m. to determine modification of the contract.

Questions arose concerning the authority to go over the Trustees' vote to pay extra funds. A consensus was taken to pay or not to pay. Four Trustees agreed to consult the Attorney prior to deciding.

Review Mileage Reimbursement for Employees

It was established that there was o policy for reimbursement for travel for daily travel to conduct Village Business. The Ordinance address travel to conferences, and the like. The \$485.00 request for travel to the bank was up for question. The Trustees, by consensus unanimously stated not to pay requests over 30-days.

## • Director Antonio Cooper

Asked for consideration to draft a resolution for a Sauk Trail and Torrence Avenue Corridor Study. Trustees noted a similar study, and the differences were discussed. The cost of the study would be \$165,000 with the Village being responsible for 5% of the cost. This item will be placed on the next Board agenda if it is readied.
