ORDINANCE NO. 20- 021

AN ORDINANCE CREATING THE POSITIONS OF FINANCE DIRECTOR, ASSISTANT FINANCE DIRECTOR, PAYROLL SPECIALIST, ASSISTANT CHIEF OF ADMINISTRATION (FIRE DEPARTMENT), AND PUBLIC WORKS DIRECTOR

whereas, the Village of Sauk Village, State of Illinois (the "Village") is a duly organized and existing municipal corporation created under the provisions of the laws of the State of Illinois and under the provisions of the Illinois Municipal Code, as from time to time supplemented and amended; and

WHEREAS, the Village has determined that the positions and duties of Finance Director,
Assistant Finance Director, Payroll Specialist, Assistant Chief of Administration (Fire Department),
and Public Works Director are necessary for the operation of the Village; and

WHEREAS, the passing of this ordinance will create the positions of Finance Director, Assistant Finance Director, Payroll Specialist, Assistant Chief of Administration (Fire Department), and Public Works Director.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Sauk Village, Cook County, Illinois as follows:

- **Section 1**. That the above recitals are found to be true and correct and hereby incorporated herein and made a part of here of, as if fully set forth in its entirety.
- Section 2. That the positions and duties of Finance Director, Assistant Finance Director, Payroll Specialist, Assistant Chief of Administration (Fire Department), and Public Works Director are necessary for the operation of the Village.

Section 3. That the positions of Finance Director, Assistant Finance Director, Payroll Specialist, Assistant Chief of Administration (Fire Department), and Public Works Director are hereby created.

Section 4. That the Finance Director, Assistant Finance Director, Payroll Specialist, Assistant Chief of Administration (Fire Department), and Public Works Director shall be responsible for all duties and responsibilities as set out by the Human Resources Director.

Section 5. If any section, paragraph or clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provisions of this Ordinance.

Section 6. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 7. This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.
