ORDINANCE No. 20-023

AN ORDINANCE FOR THE LEVY AND ASSESSMENT OF TAXES FOR THE 2020/2021 FISCAL YEAR FOR THE VILLAGE OF SAUK VILLAGE, COUNTY OF COOK, ILLINOIS

WHEREAS, the Village of Sauk Village, Cook County, Illinois is a duly organized and existing municipal corporation created under the provisions of the laws of the State of Illinois and under the provisions of the Illinois Municipal Code, as from time to time supplemented and amended; and

WHEREAS, the President and Board of Trustees have determined that it is advisable, necessary and in the best interests of the Village to levy and assess taxes for the 2020/2021 fiscal year; and

WHEREAS, in connection with the adoption of its tax levy, the Village has complied with Sections 18-60 through 18-85 of the Illinois Truth in Taxation Law (35 ILCS 200/18-60 through 35 ILCS 200/18-85), the Open Meetings Act (5 ILCS 120/1, et seq.) and all other applicable state and local laws.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Sauk Village, Cook County Illinois, as follows:

Section 1. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2: The total amount of appropriations for all corporate purposes legally made to be collected from the tax levy of the current fiscal year is hereby ascertained to be the sum of Two Million, Six Hundred Ninety-One Thousand, Three Hundred Forty-Five and 00/100 Dollars (\$2,691,345.00).

Section 3: The sum of Two Million, Six Hundred Ninety-One Thousand, Three Hundred Forty-Five Five and 00/100 Dollars (\$2,691,345.00) being the total appropriations heretofore legally made that are to be collected from the tax levy of the current fiscal year of the Village for all corporate purposes of the Village, for purposes of providing for a Police Pension Fund, Fire Fighters' Pension Fund and such other corporate purposes as permitted by statute as set forth on Exhibit "A", which is attached hereto and incorporated herein by reference, as appropriated for the current fiscal year by the annual appropriation Ordinance of the Village for the fiscal year 2020/2021, passed by the President and Board of Trustees at a legally convened meeting, be, and the same is hereby levied upon all of the taxable property in the Village subject to taxation for the current year, the specific amounts as levied for the various funds heretofore named being included in <a href="Exhibit "A", the tax so levied being for the current fiscal year of the Village, and for said appropriation to be collected from said tax levy, the total of which has been ascertained as aforesaid and being as provided in <a href="Exhibit "A", as if fully set forth herein.

Section 4: The total amount of Two Million, Six Hundred Ninety-One Thousand, Three Hundred Forty-Five and 00/100 Dollars (\$2,691,345.00) ascertained above, be and is hereby levied and assessed on all property subject to taxation within the Village.

Section 5: There is hereby certified to the Cook County Clerk the total amount of Two Million, Six Hundred Ninety-One Thousand, Three Hundred Forty-Five and 00/100 Dollars (\$2,691,345.00) which total amount the Village requires to be raised by taxation for the current fiscal year of the Village, and the Village Clerk is hereby authorized and directed to file a certified copy of this ordinance with the Cook County Clerk.

Section 6: If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance

Section 7: All ordinances in conflict herewith are hereby repealed to the extent of such conflict.

Section 8: This ordinance shall be in full force and effect following its passage, approval and publication in the manner required by law.
