**AN ORDINANCE RESCINDING ORDINANCE NUMBER 20-011 DECLARING A VILLAGE-WIDE
HIRING FREEZE AND RESCINDING ORDINANCE
NUMBER 20-012 DECLARING A VILLAGE-WIDE SPENDING FREEZE**

WHEREAS, the Village of Sauk Village, Illinois (the Village) is a duly organized and existing municipal corporation created under the provisions of the laws of the State of Illinois and under the provisions of the Illinois Municipal Code, as from time to time supplemented and amended; and

WHEREAS, the Mayor (President) and Board of Trustees of the Village of Sauk Village (the "*Corporate Authorities*") may pass ordinances from time to time as may be required for efficient governance of the village affairs; and

WHEREAS, the Corporate Authorities have determined that it is in the best interest of the health, safety and welfare of its citizenry to rescind certain ordinances which was passed by the corporate authorities.

NOW, THEREFORE, BE IT ORDAINED by the Mayor (President) and Board of Trustees of the Village of Sauk Village, Illinois as follows:

Section 1. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. That Ordinance No. 20-011 declaring a village-wide hiring freeze be repealed in its entirety. That Ordinance No. 20-011 declaring a village-wide spending freeze be repealed in its entirety.

Section 3. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance.

Section 4. All Ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 5. This ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.

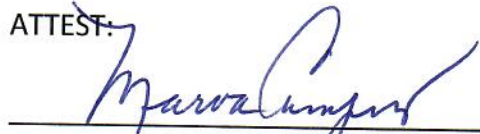

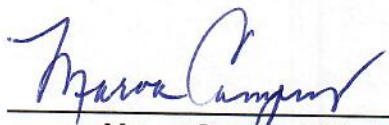
