ORDINANCE NO. 23-002

**AN ORDINANCE AMENDING ARTICLE IV "OFFICIALS AND EMPLOYEES" OF CHAPTER 2
"ADMINISTRATION" OF THE MUNICIPAL CODE OF THE VILLAGE OF SAUK VILLAGE, ILLINOIS
SPECIFICALLY AS TO THE POSITION OF HUMAN RESOURCES CONSULTANT**

WHEREAS, the Village of Sauk Village, State of Illinois (the "Village") is a duly organized and existing municipal corporation created under the provisions of the laws of the State of Illinois and under the provisions of the Illinois Municipal Code, as from time to time supplemented and amended; and

WHEREAS, the President and Board of Trustees of the Village of Sauk Village (the "Corporate Authorities") may from time to time amend the text of the Municipal Code of the Village when it is determined to be in the best interests of the Village; and

WHEREAS, the Corporate Authorities find that it is in the best interests of the health, safety and welfare of its citizenry and Village Employees to employ a Human Resources Consultant who will work and be available at the Village Hall of Sauk Village during regular Village business hours; and

WHEREAS, Sec. 2-179 of the Sauk Village Code of Ordinances entitled, "Hours of work and conditions of employment", para (c) states the hours of work and conditions of employment shall be provided by the mayor and board of trustees by ordinance; and

WHEREAS, at the April 19, 2023, Special Village Board meeting the Village Board advised the Human Resources Consultant should work at the Village Hall during regular Village Hall hours, i.e. when the Village Hall is open to the general public. The Village Board voted 5-0 directing legislative counsel to prepare an Ordinance requiring the Human Resources Consultant to work during regular Village Hall hours.

WHEREAS, at the April 19, 2023, Special Board meeting the Village Board directed the Village Attorney to amend the contract for the Human Resources Consultant to include language the Human Resources Consultant shall work in person at the Village Hall during regular Village Hall hours.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Sauk Village, Cook County, Illinois as follows:

Section 1. That the above recitals are found to be true and correct and hereby incorporated herein and made a part of here of, as if fully set forth in its entirety.

Section 2. Article IV "Officers and Employees" of Chapter 2 "Administration" of the Municipal Code of the Village of Sauk Village is hereby amended by adding (i) as follows:

DIVISION 8.- HUMAN RESOURCES CONSULTANT

Sec. 2-316. Duties

(i) **The Human Resources Consultant shall work at the Sauk Village Hall during regular Village Hall hours, i.e., hours the Village Hall is open to the public.**

Section 3. If any section, paragraph, clause or provisions of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

Section 4. Any ordinance or portion of any ordinance in conflict with any provisions of this Ordinance is hereby repealed solely to the extent of such conflict.

Section 5. This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.




