ORDINANCE No. 24-003

**AN ORDINANCE AUTHORIZING EXPENDITURES PENDING PASSAGE OF THE
ANNUAL BUDGET ORDINANCE**

WHEREAS, the Village of Sauk Village, County of Cook, State of Illinois (the "Village") is a duly organized and existing village and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code, as supplemented and amended, with the full power to enact ordinances and adopt resolutions for the benefit of its residents; and

WHEREAS, the Village previously adopted an annual budget ordinance pursuant to Section 8-2-9 of the Illinois Municipal Code (65 ILCS 5/8-2-9) for the 05/01/22 - 04/30/23 fiscal year, but has not adopted an annual budget for the current fiscal year 05/01/23-04/30/24; and

WHEREAS, section 8-1-7 of the Illinois Municipal Code (65 ILCS 5/8-1-7) permits the corporate authorities to authorize necessary expenditures upon the basis of the appropriations of the preceding fiscal year; and

WHEREAS, the corporate authorities have not yet adopted and passed an annual appropriation ordinance for the 05/01/23 - 04/30/24 fiscal year. Within the last two months a proposed budget was reviewed and discussed by the Mayor and the Board of Trustees, said proposed budget was given to the Village Clerk to be made available for public inspection; and

WHEREAS, it is necessary and in the best interests of the Village and its residents to authorize necessary expenditures upon the basis of the appropriations of the preceding fiscal year, pending the passage of the annual appropriation ordinance for the current fiscal year.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Sauk Village, Cook County, Illinois as follows:

SECTION 1: The foregoing preambles are restated and incorporated herein by reference as though fully set forth herein. This ordinance is adopted pursuant to the authority granted to the Village by the Constitution of the State of Illinois and the Illinois Compiled Statutes. All applicable provisions of the Illinois Compiled Statutes, including the Illinois Municipal Code, as may be amended from time to time, relating to the purposes of this Ordinance are incorporated herein by this reference.

SECTION 2: The Village of Sauk Village Corporate Authorities have discussed, debated, and revised the proposed budget (Attached hereto as Exh. A), and hereby approve this budget for the 05/01/23 - 04/30/24 fiscal year.

SECTION 3: If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

SECTION 4: Any ordinance or portion of any ordinance in conflict with any provisions of this Ordinance is hereby repealed solely to the extent of such conflict.

SECTION 5: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form as provided by law.
